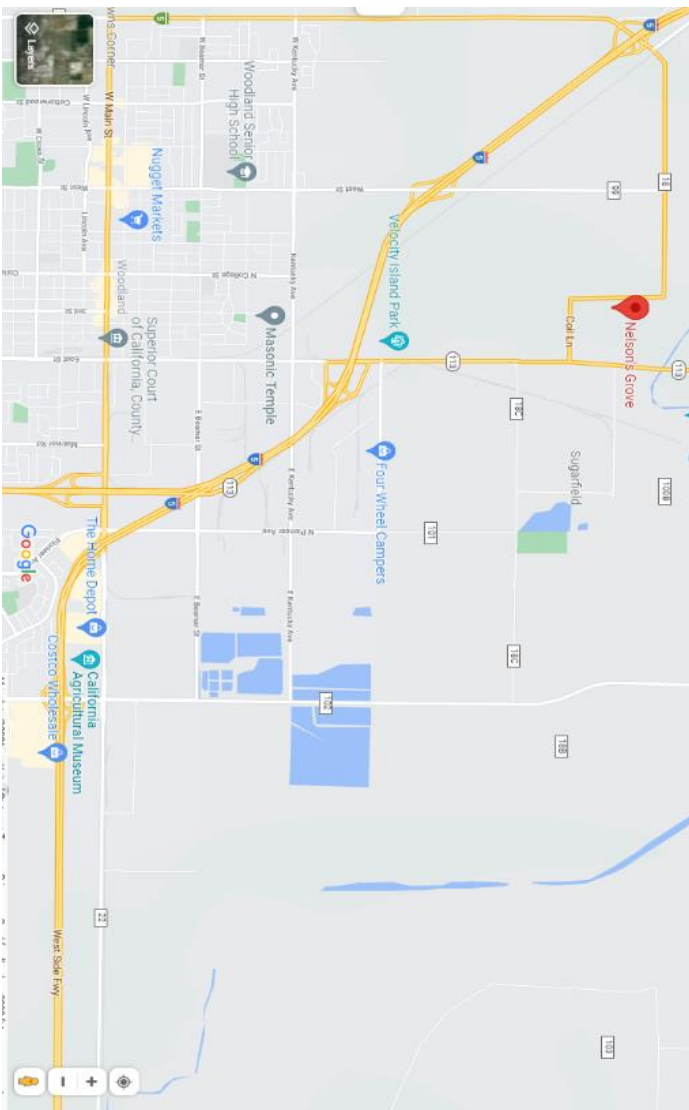

### NEW EARTHDOG NOVICE CLASS!

We are offering the new Novice class at our test. It will be offered Saturday and Sunday afternoons instead of Intro to Quarry which will be offered at the test Saturday and Sunday mornings. The Novice class is run in the same tunnels as Intro to Quarry. If you have questions, please let us know. More information about it can be found in Chapter 4, Section 7 of the Earthdog rule book: *Novice Earthdog is an instinct test requiring title to no previous exposure to earthwork. Young dogs, dogs with little working experience and novice handlers are encourage to enter. As it may be the first den experience for some dogs, the Judge and the handler shall do their utmost to assure that it is a positive experience for the dog. The Judge shall not be allowed to encourage the dog. The Judge must make sure that each handler understands the test requirements before starting the dog. It takes 2 qualifying runs to earn the Novice title (NE). The new Novice title is not a requirement to enter the Junior Earthdog tests.*

### RUNNING ORDER

Dogs in the Introduction to Quarry, Novice, Junior Earthdog, and Senior Earthdog classes will be run in the order in which their entries are received. Multiple entries by the same owner/handler will be separated to expedite the smooth running of the test. The running order for each class will be posted prior to the start of the class. Dogs not ready to run when called will be moved to the end of the running order. The judge will not wait for late arriving dogs. Dogs entered in the Master Earthdog class **must** be present on the grounds and answer to roll call at 7:30 am on the day of the test. Only those dogs present at the roll call will be deemed to be starters, and will be entered in the random drawing for ME Class running (Ch 1, Sec. 14). Dogs must be at least 6 months of age. Spayed, neutered, limited registration and ILP dogs of eligible breeds are eligible to enter. Bitches in season shall not be eligible to enter the tests (Ch 1, Sec. 6).

### NOTICE TO EXHIBITORS

The **Northern California Dachshund Club** & the **Golden Gate Dachshund Club** offer a rosette to each dog who earns a qualifying score.

**NCDC & GGDC** "Certified Earthdog" cap will be awarded to each dog that earns a title at the test, please inform test secretary.

Dogs that have earned an AKC Master Earthdog title may enter both Senior & Master classes.

**Returned checks do not constitute a valid entry fee.** The Test Secretary shall add a \$25.00 collection fee to the amount of each returned check.
