Competitors are advised that terrain, ground cover and weather are unpredictable. Good shoes, adequate layered clothing and extra water for humans and dogs to carry in the field are recommended. Do not leave dogs in vehicles unattended unless you are absolutely certain of their safety.

#### **DIRECTIONS to Hastings Island Hunting Preserve**

<u>From I-80 East-Bound:</u> Just before Fairfield, take the Highway 12 East exit. Travel east on Highway 12 toward Rio Vista. 17.4 miles from the Hwy 12 / Lawler Ranch Road intersection, you will come to Church Road. Proceed on Church Road until it "dead ends" at Airport Road. Turn left onto Airport Road. After 1 mile, there will be a fork in the road; take the right fork, which is Liberty Island Road. Follow Liberty Island Road 4 miles, where the road ascends onto a levee. Take the steel decked bridge which crosses onto Hastings Island on your left. Ignore the "no trespassing" signs but please obey the posted speed limit. After crossing the bridge, follow paved road 3.9 miles to the Clubhouse.

<u>From I-80 West-Bound</u>: Just before Dixon, take the "Highway 113 South" exit toward Rio Vista. 13.2 miles south of Dixon you will see a flashing yellow light where the Highway turns 90 degrees to the left. There is another flashing yellow light, 1 mile later where the Highway turns 90 degrees to the right. Exit the Highway at the second flashing yellow light, by driving straight ahead onto Hastings Road. Proceed 1/2 mile; the road ascends onto a levee at the intersection with Salem Road. At this point you will see "no trespassing" signs. Ignore them but please obey the posted speed limit. Hastings Island is 3.4 miles further. Prior to reaching the Island you will descend the levee onto a gravel road. When you reach Hastings Island, the road becomes paved again. Follow paved road 1 mile to the Clubhouse.

Directions from Central/Southern California: Exit NB I-5 to CA-12 W thru Rio Vista. From Rio Vista, travel west on Highway 12 toward Fairfield. About 1 mile past Rio Vista, turn right onto Church Road. Proceed on Church Road until it "dead ends" at Airport Road. Turn left onto Airport Road. After 1 mile, there will be a fork in the road; take the right fork, which is Liberty Island Road. Follow Liberty Island Road 4 miles, where the road ascends onto a levee. Take the steel decked bridge which crosses onto Hastings Island on your left. Ignore the "no trespassing" signs but please obey the posted speed limit. After crossing the bridge, follow the paved road 3.9 miles to the Clubhouse.

By signing and submitting this entry, you agree to comply with all applicable public health regulations and guidelines regarding COVID-19 in the area in which the show will be held.

General Guidelines and Best Practices for this Event

- 1. Parking areas Park with sufficient distance between vehicles if possible.
- 2. Practice social distancing by maintaining a 6-foot distance between you and others who are not from your own household. Avoid congregating to the extent possible. Gallery shall maintain social distancing while out in the field.
- 3. Please consider wearing masks when in close proximity to others.
- 4. Consider wearing disposable or washable gloves.
- 5. Avoid shaking hands or hugging; cover coughs and sneezes.
- 6. Avoid touching dogs that are not your responsibility.

#### AGREEMENT

I (WE) ACKNOWLEDGE THAT THE "Rules Applying to Dog Shows/Registration and Discipline" and, if this entry is for a Dachshund Field Trial, the "Regulations for Dachshund Field Trials", have been made available to me (us) and that I am (we are) familiar with their contents. I (we) waive any and all claims, causes of action, I (we) might otherwise have against the AKC and any AKC approved judge, judging at this trial under AKC Rules, Regulations and Guidelines. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the field trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or trial secretary and owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the field trial test premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

\*\*Dogs must be present (on event grounds) at the Time, Date, Roll Call, and Drawing of their entered Class/Stake Bracing to be officially entered.\*\*

# January 24, 2025- Open All Age Bitch

All entered OAA Bitches must be present (on event grounds) at 7:30am, when Roll Call, and Drawing of braces will begin. \*\*If the bitch is not present during Roll Call, it will be considered/marked absent and will not be included in the drawing of braces. Bitches in season are eligible to run in the OAAB class ONLY. \*1st place winner will run, if eligible, for Absolute on 1/26/2024. \*If the 1st place winners are not present at the time of Absolute judging, they will be considered/marked absent.

# January 25, 2025- Open All Age Dog

All entered OAA Dogs must be present (on event grounds) at 7:30am, when Roll Call, and Drawing of braces will begin. \*\*If the dog is not present during Roll Call, it will be considered/marked absent and will not be included in the drawing of braces. \*1st place winner will run, if eligible, for Absolute on 1/26/2024. \*If the 1st place winners are not present at the time of Absolute judging, they will be considered/marked absent.

# January 26, 2025- Field Champion Combine Sexes

All entered Field Champion Combine Sexes must be present (on event grounds) at 7:30am, when Roll Call, and Drawing of braces will begin. \*\*If the dog/bitch is not present during Roll Call, it will be considered/marked absent and will not be included in the drawing of braces. \*Bitches in season are ineligible to run in this offered class/stake. \*1st place winner will run, if eligible, for Absolute on 1/26/2024. \*If the 1st place winners are not present at the time of Absolute judging, they will be considered/marked absent.

\*\*The 1st place winners of all classes will run, if eligible, for Absolute on 1/26/2024. \*If the 1st place winners are not present at the time of Absolute judging (after Field Champions have finished being judged), they will be considered/marked absent.\*\*

The field trials will be held regardless of weather. All dogs and handlers must be off the field by 4:30 p.m. per the Hunting Preserve's rules.
